- prepare and modify surfaces for gilding; if necessary complement their missing parts;
- colour and plate leaf tint on different types of material surfaces;
- carry out gilding work according to the drawings, to the original designs or graphic designs with appropriate technological processes;
- carry out final fitting of the products and finish products with regard to the desired functional and aesthetic characteristics;
- repair and make reconstruction of damaged parts of the original work;
- use the relevant standards and regulations in the field of conservation;
- prepare the initial and subsequent documentation for the specific job;
- service and perform routine maintenance of machinery, equipment, tools and instruments.
